This Memorandum of Understanding (**MoU**) is entered between a company incorporated under the Indian Companies Act, 1956 having its registered office, and represented by its undersigned of the ONE PART;

And **S. SINHA COLLEGE**, Aurangabad, Bihar represented by undersigned of the OTHER PART;

Whereas Ambition Learning Solutions and **S. SINHA COLLEGE** shall be hereinafter jointly referred to as the “Parties” and singularly as a “Party”.

The Parties have decided to agree to establish industry-academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (**MoU**), Ambition Learning Solutions and **S. SINHA COLLEGE** agree on the following activities:

1. **Ambition Learning Solutions** will provide support for designing the course curriculum at **S. SINHA COLLEGE** which would be relevant for industry. To achieve this, senior officials from Ambition Learning Solutions will work in close collaboration with faculty members of **S. SINHA COLLEGE**. 4. **Ambition Learning Solutions** shall release offers to students of **S. SINHA COLLEGE** through campus placements before the end of the academic term and shall absorb them at the end of their graduation term.
5. **S. SINHA COLLEGE** shall provide students and arrange for placements on campus for the representatives of Ambitions Learning Solutions by providing student details and mediating all communications.

Each party shall appoint a nodal officer to periodically review and identify ways to strengthen cooperation between them.

This **MoU** will effect from the date signed by the representatives of the parties. It will remain valid for three years and may be continued thereafter after suitable review and agreement. Either party may terminate the **MoU** by giving written notice to the other party. Once terminated, neither Ambition Learning Solutions nor **S. SINHA COLLEGE** will be responsible for any losses, financial or otherwise, which the other party may suffer. However, Ambition Learning Solutions and **S. SINHA COLLEGE** will ensure that all activities in progress are allowed to be completed successfully.
